Know the weather condition before heading to work or school by listening to the weather and travel advisories.

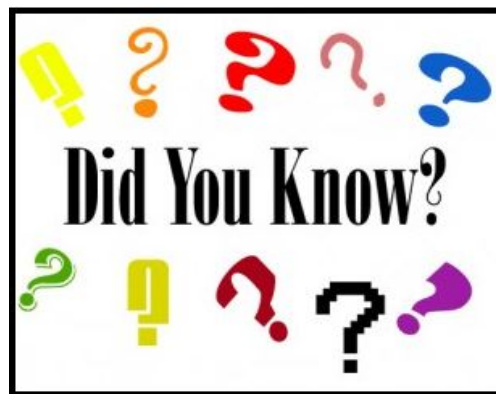
For the Southwestern Pennsylvania region PennDOT has a user friendly website or application for cell phones, check out their website for more information at <http://www.511PA.com>.

The Southwestern Pennsylvania Commission (SPC) hereby gives public notice that it is the policy of the Commission to assure full compliance with Title VI of the Civil Rights Act of 1964, the Civil Rights Restoration Act of 1987, Executive Order 12898 on Environmental Justice, and related statutes and regulations in all p es.
