## Remember Emergency Ride Home During Cold & Flu Season!

Between back to school and temperatures taking a dip, September is prime time for cold and flu season. If you rideshare, you know that getting sick or other types of emergencies can be difficult to prepare for with the other poolers.

All current CommuteInfo registered vanpool, carpool, bikepool participants, as well as many registered transit riders are eligible for the Emergency Ride Home reimbursement program. If you find you need to leave work early for an emergency, simply get yourself home and mail in your receipt to CommuteInfo using this form.

The most important thing is to be safe and plan ahead! If you're in a pool now, discuss your options with your fellow poolers today.

What counts as an emergency?

- Unscheduled overtime or late meeting
- Sickness or accident (self or immediate family member)
- Breakdown of carpool vehicle
- Carpool partners or vanpool driver had to unexpectedly leave work early

The Southwestern Pennsylvania Commission (SPC) hereby gives public notice that it is the policy of the Commission to assure full compliance with Title VI of the Civil Rights Act of 1964, the Civil Rights Restoration Act of 1987, Executive Order 12898 on Environmental Justice, and related statutes and regulations in all programs and activities. Title VI and other related statutes require that no person in the United States of America shall, on the grounds of race, color, sex, national origin, age, or disability, be excluded from the participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity for which SPC receives federal financial assistance. Any person who believes they have been aggrieved by an unlawful discriminatory practice by SPC under Title VI has a right to file a formal complaint with the Commission. Any such complaint must be in writing and filed with SPC's Title VI Coordinator within one hundred eighty (180) days following the date of the alleged discriminatory occurrence.
